Optional/General comments	1. Introduction Section	
	The study objective was to identify coping strategies adopted by female agripreneurs in the face of	
	food system discrepancies caused by climate change. However, in the introduction section, only one	
	thing is discussed, which is the impact of climate on agriculture. Other relevant areas of the paper,	
	such as food system discrepancies as the problem, women agripreneurs and coping strategies, are	
	not discussed anywhere in the introduction section.	
	2. Reasons for rejection.	
	According to my evaluation, the manuscript should be rejected mainly because the methodology	
	adopted by the author to achieve the objective is not sound and failed to achieve the objective of the	
	study.	
	Firstly, the paper focuses on the identification of coping strategies adopted by female agripreneurs for	
	discrepancies caused by climate change. However, in methodology, analysis, and discussion, the	
	author has not mentioned even a single coping strategy, ultimately failing to achieve the objective of	
	the study.	
	Second, the dependent variable is "ownership of the business", the selection of which is not argued	
	and justified and for the purpose of achieving the objective selection of "ownership of the business" as	
	the dependent variable is irrelevant and unnecessary. Due to this particular reason, the whole study	
	Finally, the paper used observed discrepancies within the food system as explanatory variables,	
	which again does not help in any way in achieving the objective of the study.
