For example, there are too many pronouns in the paper, so confusing which one is refer to what or whom. Another example is there are some filling sentences which are not important or merely describing the facts without clear arguments.	
Optional/General comments	I am struggling to read this paper as I could not find the pieces of evidence until page 19, so 19 pages are seemingly describing without clear arguments. So, better you start each paragraph with a clear topic sentence with your argument, then build the paragraph by supporting with pieces evidence and scholarly debates on that evidence, istead of merely describing things or problems without strong pieces evidence. Also, better you reconstruct and organize your paper based on three specific topics; for example, how the women challenge those patriarchy and tyranny based on three topics: politics, religion, and social taboo, then you can focus in building up your arguments; instead of mixing everything there: mixing various problems, mixing countries, and mixing the time periods.
