The literature support seems adequate, with references drawn from various studies. However, the recency and depth of the referenced literature could be improved. For instance, some citations are quite dated (from the 1930s), and balancing these with more recent studies would enhance the article.	
Is the language/English quality of the article suitable for scholarly communications?	The English grammar is generally good, but there are a few writing errors and misplaced expressions (e.g., "Demonstrative A demonstrative examples"). These linguistic issues should be corrected.	
Optional/General comments	The article describes the clinical and psychiatric features of KLS but does not explain the methodology in detail (e.g., how the literature review was conducted). How were the psychiatric symptoms analyzed? How were the patient samples selected? The inclusion of Table 1 is helpful in summarizing the data. However, adding more visuals (e.g., graphs showing the distribution of cases) could enrich the article visually. The conclusion emphasizes that KLS should be regarded as a neuropsychiatric disorder rather than merely a sleep disorder. However, the reasoning leading to this conclusion should be clarified further. Incorporating more recent studies would significantly enhance the academic contribution of the article.
